TERMS & CONDITIONS

1. All entrants (residents and businesses) must be within the Beachmere MBRC boundaries. Boats to be seen from a road safely.
2. Entry Fee - \$10 to be included with nomination form or bank transfer BSB: 633 000 A/C 155341407 : Reference your SURNAME.
3. Entries close **7pm Sunday, 9 December 2018**. Late entries will not be accepted. Judging will occur between **10 & 14 Dec** including People's Choice.
3. Displays are to be visible from the street frontage of the address nominated.
4. All entrants understand that their property may be photographed, and these photos may be used for promotional purposes.
5. The judges' decision will be FINAL. Judges are independent and not a member of the BANG Management Committee. Creativity, originality and Illumination will be considered.
6. All Entrants should ensure that their displays **are illuminated by 7pm 9 December 2018. Judging will occur between 10 & 14 Dec.**
7. Entrants must take into consideration their local environment and neighbour,s and must ensure their displays present no danger to the general public. Consideration must be given to noise and the levels of light emitted by your display.
8. Entrants agree to their street name being published for inclusion in the Christmas Lights Trail, on Facebook and on BANG website.
9. Entrants are reminded that it is their responsibility to comply with any safety matters or regulations relating to electrical fittings. If any doubt exists, the entrants should consult a licensed electrician.
10. Categories are: Best RESIDENCE : Runners Up RESIDENCE : Best BUSINESS : Best BOAT : Best STREET ⁽¹¹⁾ : PEOPLE'S CHOICE ⁽¹³⁾.
11. Best STREET Category will be awarded for a street with FOUR (4) paid sites, if not enough" paid sites" it will be decided at the discretion of the judges. Signs will be provided for winners to clearly mark for trail viewers.
12. All entrants will receive a "SIGN" with a "number" allocated from BANG for clear display so judges can determine entrants. This will be dropped off to your letterbox by 10 December and required to be on view by your house number/letterbox for judging from from 7pm between 10 and 14 December.
13. PEOPLE'S CHOICE - with SIGN provided, locals viewing your display will be able to Vote your "number" as many times as they like on a piece of paper and leave in box located at shops around Beachmere.
