### BUMP IN / BUMP OUT:

Bump In is from 2pm vehicle access via Moreton Terrace (near the Bus Stop) with all unnecessary vehicles to be removed from the Park by 3.45pm. Bump Out commences after 7pm or as determined by Site Manager due to delay of patrons leaving the area.

## No vehicle will be allowed to enter or leave the Park until this time.

- 6. All marquees must be weighted (clearly visible) to ensure no movement due to strong winds. **DEFINITELY NO TENT PEGS ALLOWED**.
- 7. All leads, hoses or other trip hazards must be suitably covered to prevent any trip hazards.
- 8. All equipment brought onto the site is the responsibility of the stall holder and BANG shall not be held liable for any loss or damage to the property while at the Event for any reason whatsoever.
